## Multipliers

There are no multipliers in any misdemeanor case. Any changes made to misdemeanor bonds will be based upon the guidelines set for in the policy and will remain reasonable.

One multiplier only is used, as appropriate. The following are felony multipliers, for non-drug' and drug cases:

Deadly weapon -
Exhibition/threat/or use, add $\$ 15,000$; or bodily injury by deadly weapon, add \$40,000.

Residency -
Non-resident alien, out of state resident, questionable residence: three (3) times amount of schedule bail.

Criminal record -Includes any prior arrest, whether convicted or not: two (2) times amount of schedule bail.

## Bond Not Within Schedule

This schedule does not cover an offense or contraband amount that is not listed herein.
